If you have elected to receive your distributions by direct deposit, it can be one to two business days for distribution, depending upon your financial institution of choice. Shareholder Services strongly encourages all Beneficiaries to sign up for direct deposit. Beneficiaries can sign up for direct deposit distribution on www.mycapexfox.com. All Beneficiaries are recommended to visit www.mycapexfox.com to verify their information is correct.
