## Sustainable Tourism

For fifty years, CFC has been committed to advancing our Tlingit culture and supporting our Tlingit shareholders from the Village of Saxman, Alaska. To that end, CFC and all its subsidiaries are committed to providing tourists to our shores with a focus on their Alaska adventure that includes cultural tourism and sustainability.

CFC is dedicated to keeping Alaska true to its beauty, the culture and history of the land, the businesses that support our economy, and the natural environment around us, giving tourists a true Alaskan journey.

### What is Sustainability?

So what is sustainable tourism? Sustainable tourism is the intentional effort to minimize negative environmental, social, and economic impacts while maximizing positive ones, balancing the needs of visitors,

the tourism industry, the environment, and communities for long-term value. It involves responsible practices such as resource conservation, community support, cultural preservation, and a commitment to sustainability principles in planning and management.

### Why Sustainable Travel Matters

**Minimizes Negative Impacts:** Tourism can lead to environmental degradation, cultural disruption, and economic disparities. Sustainable travel aims to reduce these harmful effects.

**Supports Local Communities:** It ensures that the economic benefits of tourism are distributed to the local population, fostering job creation and cultural preservation.

**Protects Ecosystems:** By reducing pollution and respecting natural habitats, sustainable travel helps conserve biodiversity and vital life support systems for the future.

**Preserves Cultural Integrity:** It encourages respect for local traditions

and cultures, ensuring they are not commodified or negatively impacted by tourist influx.

## Why Sustainability Matters

**For the Planet:** By reducing our consumption and protecting natural systems, we help to mitigate climate change and ensure the health of ecosystems that support life.

**For Future Generations:** It ensures that the resources and stable environments that we rely on today will still be available for our children and grandchildren.

**For Business:** Companies that adopt sustainable practices can innovate, improve their reputation, attract investors, and develop new growth opportunities, creating long-term financial stability, according to Harvard Business School.

**For Individuals:** Small actions, like recycling, reducing energy consumption, and making conscious purchasing choices, contribute to a larger effort to create a more sustainable world.

## CFC's Pillars of Sustainability

CFC has created a Green Alaska program that includes four pillars of sustainability, including:

- **Economic** – We work toward supporting small businesses within the community.
- **Cultural** – We offer programs that advance education and promote the culture and history of Alaska Native people.
- **Environmental** – Just as our ancestors did, we protect the land where we live and the environment around us.
- **Social** – We maintain close ties and relationships with our staff, partners, and our community.

## Examples of Sustainable Practices at CFC

With our four pillars of sustainability in mind, CFC has been devoted to our Green Alaska program for Tourism Season 2025. Cape Fox Tours (CFT) has earned an Adventure Green Alaska certification for demonstrating compliance with its sustainable tourism practices. Adventure Green Alaska is the only sustainable tourism certification in the state of Alaska. Some examples of our sustainable practices with CFT are:

- **Utilizing Propane Vehicles** more frequently to reduce emissions from diesel ran vehicles.
- **Encouraging Employees to Bike or Walk** to work. CFT offers one shuttle service in the morning and afternoon when the local bus is not running for employees to get to work.
- **CFT put a Water Dispenser** in the village store to encourage guests and staff to use reusable water bottles. CFT

also encouraged people to purchase a reusable water bottle.

• **Recycling Kegs.** Beer kegs are picked up by the distributor after use so that they can be cleaned and reused for other vendors.

• **CFT is Hosting Local Elementary Schools** for tours throughout Saxman and the SE Discovery Center.

CFC has put intentional thought into implementing the standard values for sustainability into its business model and remains committed to efforts to further sustainability within the tourism industry. CFC ensures that its business operations are conducted sustainably, from internal management to the products and services customers receive. # 2025 Mid-Year LANDS REPORT

It has been a busy year for the Cape Fox Corporation (CFC) Lands Management team, which is often tasked with assessing compliance, reducing liability, strategizing growth, and developing policy and procedures. The Lands team is instrumental in growth and development as they help guide, develop, and recommend Lands issues, which eventually are brought before the Board for final decision and adopted policy.

The Lands Management team has been working diligently toward completion of several grants that support the community, including:

- George Inlet Cannery
- United States Forestry Service (USFS) Temporary Bridge (6-bridge purchase)
- Natural Resources Conservation Service (NRCS) Precommercial Thinning
- Mahoney Lake Road improvement

The development and maintenance of CFC infrastructure allows access for subsistence and creates future revenue opportunities. CFC has over 125 miles of road crossing its land.

**Coon Cove Road** - A mutual road use easement is being negotiated with AK Mental Health Trust (AMHT) to ensure access from the State Highway, Shelter Cove Road, to the Coon Cove LTF.

**CFC Lands Bill** – House bill H.R. 2815 and Senate bill S.1008 are the legislative vehicles that will convey the remaining 180-acre entitlement of ANCSA to CFC. Senators Murkowski and Sullivan reintroduced the Senate Bill at the beginning of the


119th Congress in January. Representative Begich introduced the Bill in the House of Representatives, and it successfully made it through the Committee on Indian Affairs and the Natural Resources Committee. It appears to have passed through rewrite, where minor edits occurred. It is currently waiting to be attached to legislation for passage before going to the President for signature.

**George Inlet Cannery** – The AK State Historical Preservation Office (SHPO) required that CFC perform a “Grey Literature Study” of the George Inlet cannery history as part of the U.S. Corps. of Engineers Permit. CFC hired Charles Mobley, an approved SHPO archaeologist, to perform the study. It is complete.

**Temporary Bridge Program** - The 6- Big R bridges bought from Contech Corporation have arrived in Ketchikan and will be staged at Coon Cove and White River LTFs. One 16' x 70' bridge will be installed on Rainbow Creek. The other five bridges will be stored at the White River LTF and are awaiting funding for installation.

**Precommercial Thinning (PCT)** – The NRCS has been working with CFC to bring all timber lands current with PCT. The year has had a slow start due to the Federal Grant Review. Currently, all the scheduled PCT on CFC lands have been fully funded. The 2025 contracts will start in August. Sealaska administers this program.

**NRCS Culvert Replacement** - THE NRCS Staff and the Southeast Watershed Coalition have been doing Fish Habitat Enhancement projects on CFC lands for the past three years. They also plan to pay for a culvert/bridge replacement in Talbot Creek. CFC has been working with NRCS engineers to do preliminary stream surveys. These will be 100% funded projects requiring no CFC finances. ■



## 52<sup>nd</sup> Annual Meeting of Shareholders and Election of Directors

Preparations for the 52nd Annual Meeting of Shareholders and Election of Directors (Annual Meeting and Election) are underway. This year's Annual Meeting will occur Saturday, October 25, 2025, and will again be at the Ted Ferry Civic Center in Ketchikan, Alaska. For anyone unable to attend this meeting in person, a live stream of the event will be available on [MyCapeFox.com](http://MyCapeFox.com). As we prepare for the upcoming Annual Meeting and Election, there are several dates to keep in mind.

- **2025 CFC Director Nomination packets** were sent out. The Director Nomination period opened on July 7th and ran through August 11th. The Director Nomination Period is closed.
- **The CFC Nomination Committee** held a meeting on August 25th to approve candidates to run for a position on the CFC Board of Directors. All approved candidate names are listed on the CFC Proxy Statement and the official CFC Proxy that was mailed out to all shareholders of voting stock as of the record date on September 15th.

- **You can vote your shares by proxy**, even if you cannot attend the Annual Meeting and Election in person. If you are unable to participate in the Annual Meeting and Election in person, CFC encourages and recommends that you vote in advance by proxy. Proxy votes will be due to the Inspector of Elections, Elgee Rehfeld, LLC, 9309 Glacier Hwy, Suite B-200, Juneau, AK 99801, by the **Proxy deadline at 5:00 p.m. AKST on Thursday, October 23rd**. The Inspector of Elections must receive your proxy prior to the Proxy Deadline to be voted at the Annual Meeting and Election. Any Proxy received after the Proxy Deadline will not be voted on at the Annual Meeting and Election.

- **October 25th – Annual Meeting and Election.** You can still vote in person at the Annual Meeting instead of voting by proxy on Saturday, October 25th.

All shareholders are invited and encouraged to attend. We look forward to seeing everyone on **Saturday, October 25, 2025**, at the **Ted Ferry Civic Center** (venue subject to change). ■

## EAGLES NEST



Finally, CFL installed a new tram intercom system. This means that locals and hotel guests will be able to use the tram throughout the fall and winter. ■






## CAPE FOX FEDERAL CONTRACTING GROUP **HIGHLIGHTS**


